OFFICE ORDER

In pursuance to the directions of Government and in supersession of this office orders No-2-28/2024-EXN-H-Estt-23093-23235 and 23236-23357 dated 13-09-2024 and in pursuance to the Notification No- EXN-B-(1)-1/2021 dated 19-01-2024, 29-01-2024 and 29-08-2024 issued by the Department of State Taxes and Excise, Government of H.P, whereby restructuring of the State Taxes and Excise Department into two wings viz. Excise Wing and GST Wing has been effected. The following State Taxes and Excise Officers (STEOs) and Asstt. State Taxes and Excise Officers (ASTEOS) of this department are hereby adjusted in the **Excise / GST Wing of the Department** and stand relieved immediately. 
All relieved officers shall report at the new places of posting immediately. TTA and joining period shall only be applicable in the cases of transfers from their present place of postings as per Rule.
