- 1. That the official will be entitled for pay in level 4 Cell -1 (₹ 20,600/-)as per notification No. Fin-(PR)(7)-1/2021 dt. 3<sup>rd</sup> January 2022 and other allowances.
- That the official can be removed from Govt. service by giving one month notice without explaining any reason. This notice can be given from any party i.e. Government or official side. The appointing authority shall have the right to end his/her services by paying an amount equal to the salary and allowances for one month only.
- 3. That the official will remain on probation for a period of two years.



- 4. That the official can be posted on appointment/transferred at any place in HP(including tribal area) as per administrative requirement.
- 5. They will submit a certificate of fitness from the (CMO) District Hospital.
- 6. That No travelling allowances will be given to the official for joining/appearing on duty.
- 7. They shall have to produce an affidavit to the effect that there is no court case/criminal/vigilance or appeal thereof pending for adjudication in any Court of Law in or outside the State of Himachal Pradesh against them.(to be submitted at the place of posting)
- 8. That the official shall submit a certificate or order of acceptance of technical resignation from the previous Department, if already employed.

If the offer of appointment, on the above terms and conditions is acceptable to candidate, he/she will report for duty at the place of his/her posting on or before 30.10.2024 positively. They are further directed to execute the affidavit as stipulated in condition No. 7 above on the stamp paper of ₹10/-(Ten Rupees). In case the candidate is not interested, than send the same in writing to this office within 15 days from the date of issue of these orders, failing which the offer of appointment shall automatically stand cancelled and the candidate will have no right to claim it.

The appointment shall be considered **provisional** till the verification of character and antecedents, which will be carried out on the basis of self declaration form, submitted by the candidates at the time of joining duties, certifying therein that all facts and detail given are correct. In case, character and antecedents of the candidate are not found verified or any false information is given by the candidates in self declaration, the provisional appointment will be cancelled forthwith and criminal legal action will be taken as a consequence.
