## TERMS & CONDITIONS OF APPOINTMENT ARE AS UNDER:-

- 1. That the official will be entitled for pay in level 4 Cell -1 ( $\stackrel{?}{\sim}$  20,600/-)as per notification No. Fin-(PR)(7)-1/2021 dt.  $3^{rd}$  January 2022 and other allowances.
- 2. That the official can be removed from Govt. service by giving one month notice without explaining any reason. This notice can be given from any party i.e. Government or official side. The appointing authority shall have the right to end his/her services by paying an amount equal to the salary and allowances for one month only.
- That the official will remain on probation for a period of two years.
- 4. That the official can be posted on appointment/transferred at any place in HP(including tribal area) as per administrative requirement.
- 5. They will submit a certificate of fitness from the (CMO) District Hospital.
- 6. That No travelling allowances will be given to the official for joining/appearing on duty.
- 7. They shall have to produce an affidavit to the effect that there is no court case/criminal/vigilance or appeal thereof pending for adjudication in any Court of Law in posting)



- 8. That the official shall submit a certificate or order of acceptance of technical resignation from the previous Department, if already employed.

The candidates appointed under 1% quota for Visually Impaired have been exempted from acquiring Diploma in Computer Science/Computr Application/Information Technology and passing of typing test subject to necessary basic training including computer training course by the Department concerned through Composite Regional Centre(CRC), Sundernagar or National Institute for the visually Handicapped(NIVH), Dehradun or Composite Training Centre(CTC), Ludhiana. Further they have to complete the above training for which three chances will be afforded. If the incumbent fails to qualify the same his services shall be terminated.

If the offer of appointment, on the above terms and conditions is acceptable to candidate, he/she will report for duty at the place of his/her posting within 15 days from the issuance of these orders positively.
