### **OFFICE ORDER**

With a view to ensuring strict enforcement of Model Code of Conduct to be announced by the Election Commission of India for the forthcoming General Election to H.P. Legislative Assembly Election and further to ensure meticulous adherence to the provisions of the H.P. Excise Act, 2011 and Rules and the NDPS Act in the State to prevent illegal smuggling, sale and transportation of liquor, illicit manufacturing of liquor etc. together with checkings and surveillance of manufacturers/ Bottling Plants/Breweries/Wineries and liquor Vends across the State and to redress the complaints received through online and telephones and further to coordinate with the State level, Zonal level and Distt. Level Nodal Officers, Conference Hall in the Office of the Commissioner of State Taxes & Excise, Himachal Pradesh, Block No. 30, S.D.A. Complex Kasumpti Shimla, 171009, is hereby notified as Control Room which will function 24X7 from the announcement of legislative Assembly Election and enforcement of Model Code of Conduct till the completion of election process. The Control Room will be responsible to register the complaints received with regard to violation of Model Code of Conduct relating to Excise and NDPS Acts by maintaining proper record and further to transmit to the District, Zonal and State Level Nodal Officers. The following officials are hereby deputed to perform duties in the aforesaid Control Room round the clock i.e. 24X7 as per roaster to be devised and ensure strict compliance of directions of the Election Commission of India/Chief Electoral Officer of HP:-
